As you are aware, VPDES permit holders are required to submit to Virginia Division of Mined Land Reclamation (DMLR) a quarterly Discharge Monitoring Report (DMR) that summarizes effluent quality. Environmental Monitoring, Inc. (EMI) has been notified by DMLR that permit holders can now submit their DMR information online, as an alternative to paper or CD form submission. Using an electronic process for submitting reports can represent significant labor savings while increasing the timeliness, accuracy, and overall reliability of this information. Electronic submittal will allow EMI to provide a more seamless process to present files to our clients and will improve DMLR's water program's overall effectiveness with faster and more accurate response to data analysis, compliance assessment, and decision-making. The e-DMR format when viewed through the DMLR e-Forms interface also allows the responsible party a much easier format for data review.

The Division of Mined Land Reclamation is conducting Industry E-Forms training in an effort to assist companies in the understanding of new opportunities available utilizing electronic submittal of not just DMR information but many other aspects of the mining industry.
